No/F-49/1/2007/42-1 In exercise of the powers conferred by sub-section (1) of Section 38, read with Section 37 of the Rajiv Gandhi Proudyogiki Vishwavidyalaya Adhiniyam, 1998 (No. 13 of 1998), the State Government hereby makes the following first Statute for the Rajiv Gandhi Proudyogiki Vishwavidyalaya, namely: -

STATUTE-34

1. **Short title and commencement:**

- (1) This Statute may be called the Rajiv Gandhi Proudyogiki Vishwavidyalaya (**Sports Committee**) **Statute, 2007;**
- (2) This shall come into force with effect from the date of publication in the Madhya Pradesh Gazette.

2. **Definitions:** In this statute, unless the context otherwise requires;

- (a) **“Adhiniyam”** means the Rajiv Gandhi Proudyogiki Vishwavidyalaya Adhiniyam, 1998 (No 13 of 1998);
- (b) **“Statute”** means the Statute made under the provisions of Section 37 and 38 of the Rajiv Gandhi Proudyogiki Vishwavidyalaya Adhiniyam, 1998 (No 13 of 1998);
- (c) **Words and expression** used but not defined in this statute shall have the meaning as assigned to them in the Adhiniyam.

3. For the purpose of promoting Sports and Physical Welfare of the students there shall be a Sports Committee which shall consist of;

- (a) The Kulpati–Ex-Officio-Chairperson.
 - (b) Two Principals of colleges and not more than 3 Professors of the University Teaching Departments or School of Studies nominated by the Kulpati.- Member
 - (c) Three teachers of the affiliated colleges one of whom shall be a lady teacher and one Teacher of the School of Studies or Teaching Department nominated by the Kulpati.- Member
 - (d) Two persons of whom at least one shall be a non-teacher appointed by the Executive Council. - Member
 - (e) Not more than two persons possessing Expert knowledge or Experience of a branch or branches of Sports to be co-opted by the Sports Committee. - Member
 - (f) Two Physical Training Instructors of Colleges or Schools of Studies or Teaching Departments nominated by the Kulpati. - Member
 - (g) The Registrar. - Member
 - (h) The Captains of University teams in the proceeding year nominated by the Kulpati. - Member
 - (i) The Director of Physical Education - Ex-Officio-Secretary.
4. The term of all members except ex-officio members and members under item (h) of para 4 above shall be three years. The term of members under item (h) shall be one year. Five members shall form a quorum. Ordinarily no member shall be eligible for nomination for a second consecutive term.
5. The Sports Committee shall meet ordinarily twice every year. The date for the meeting shall be fixed by the Secretary with the approval of the Kulpati.
6. In the absence of the Kulpati members present shall elect Chairperson who shall preside the meeting
7. **Powers and functions of the Sports Committee:-**
- (1) Subject to control of the Executive Council the Sports Committee shall organize, control, manage and supervise either by itself or through various sub-committees. The inter-Collegiate Sports and Tournaments and to Foster, undertake inter-University Competition.

- (2) The Sports Committee shall subject to the approval of the Executive Council frame and adopt all rules to be followed by all the constituent and affiliated colleges and schools of studies and teaching departments of the University.
- (3) It shall decide whether the University shall participate in the Inter-University competitions and prepare the budget for the expenses involved in such participation subject to the overall budgetary limits laid down by the Executive Council.
- (4) The Committee shall have the power: -
 - (a) to appoint Organizing Committees, to conduct and arrange Inter-University competitions whenever required,
 - (b) to issue certificates of proficiency in games to the players,
 - (c) to conduct Inter-Collegiate Sports Tournaments,
 - (d) to appoint Selection Committees to choose University teams for Inter-University Tournaments,
 - (e) to prepare budget for approval of the Executive Council,
 - (f) To appoint Managers, Coaches and Captains for team participating in Inter-University Tournaments,
 - (g) to propose disciplinary action against the players and college teams for violation of the Sports rules, Regulations and for misconduct either on the playground or outside,
 - (h) to prepare Annual Report of the Sports activities,
 - (i) to frame modify or amend rules for the efficient control and carrying out the activities of sports,
 - (j) to award Crest and Certificates or both to the players and competitors participating in Inter-University or Inter-Collegiate Tournaments,
 - (k) to organize physical training in the colleges and schools of studies or teaching departments of the University,
 - (l) to advise the Executive Council on all the matters connected to sports and games in the colleges, schools of studies and teaching departments, and;

- (m) to take such steps as may be necessary in due discharge of their responsibilities and to perform such functions as may be assigned by the Executive Council,
