

Dear Sir/Madam,

I am directed to state that the Executive Committee of the Council of Architecture (COA), considered the reply/information submitted by your institution in response to the show cause issued by the Council to your institution for reduction in intake in the 5-year full-time Bachelor of Architecture (B.Arch.) degree course for the academic session 2022-2023.

The Executive Committee, after going through the same, observed following deficiencies related to faculty in Architecture and/or physical & academic infrastructure facilities in the conduct of said course at your institution:

- Faculty is severely deficient as per COA Norms.
- No eligible Head is appointed.
- No regular faculty is available. There are only contract and visiting faculty and inadequate in number.
- The salaries are not as per CoA norms.
- There is no library in the school premises. School is using the General Library of the University. The number of books there are inadequate.

Accordingly, the Executive Committee of the Council of Architecture has decided to fix the intake of your institution in the B.Arch. degree course to **Zero** for the academic session 2022-2023, subject to compliance of the Council Norms attached herewith as **Annexure-A**. The institution shall not make any new admissions for 2022-2023.

The approval accorded to your institution (including previous batches) shall be subject to appointment of adequate Faculty of Architecture and maintenance of physical infrastructure & facilities at your institution in terms of Council of Architecture (Minimum Standards of Architectural Education) Regulations, 2020, prior to commencement of academic session 2022-2023. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The final observations of the Council are mentioned below for your information and compliance:

- Adequate Infrastructure and cadre-wise qualified faculty as per COA Norms should be appointed/maintained by the institution at all times.



The institution shall initiate necessary remedial actions, if any, based on the observations of the Council and/or Inspection Committee and send its compliance/observations on the same for further consideration.
