No/F-49/1/2007/42-1 In exercise of the powers conferred by sub-section (1) of Section 38, read with Section 37 of the Rajiv Gandhi Proudyogiki Vishwavidyalaya Adhiniyam, 1998 (No. 13 of 1998), the State Government hereby makes the following first Statute for the Rajiv Gandhi Proudyogiki Vishwavidyalaya, namely: -

STATUTE-32

1. **Short title and commencement;**
 - (1) This Statute may be called the Rajiv Gandhi Proudyogiki Vishwavidyalaya (**Administration Of Endowments**) Statute, 2007;
 - (2) This shall come into force with effect from the date of publication in the Madhya Pradesh Gazette.
2. **Definitions;** In this statute, unless the context otherwise requires;
 - (a) “**Adhiniyam**” means the Rajiv Gandhi Proudyogiki Vishwavidyalaya Adhiniyam, 1998 (No 13 of 1998);
 - (b) “**Statute**” means the Statute made under the provisions of Section 37 and 38 of the Rajiv Gandhi Proudyogiki Vishwavidyalaya Adhiniyam, 1998 (No 13 of 1998);
 - (c) “**Section**” means Section of the Adhiniyam;
 - (b) **Words and expression** used but not defined in this statute shall have the meaning as assigned to them in the Adhiniyam.
3. The Executive Council may accept donations for the creation of an endowment, for the award of fellowships, scholarships, studentships, exhibitions, bursaries, medals and other awards of a recurring character.

- 4 (1). Each endowment shall be secured by investment in securities described in Section 20 of Indian Trusts Act, 1882 or in immovable property in India. Money received in cash shall be invested by the Executive Council in any of the securities referred to above or in fixed deposits in a scheduled bank.
 - (2) The value of the endowment necessary for instituting an award shall be prescribed by the Executive council.
5. No endowment shall be accepted in contravention of the provisions of clause (f) of Section 7 of the Adhiniyam.
6. The Executive Council shall be the administrator of all endowment.
7. The award shall be made out of the annual income accruing from the endowment any part of the income which is not so utilized shall be added to the endowment.
8. The Academic Council shall prescribe the conditions of award after consulting the donor and effect shall be given to his/ her wishes as far as possible
9. In case of each endowment accepted by the Executive Council shall make a regulation giving the name of the donor, the name, initial value and purpose of the endowment.
10. **No two endowments** shall confer/award on the same candidate for the same purpose in the same year.
