- RGPV reserves the right to withdraw this EoI if RGPV determines that such action is in the best interest of the University.
- Timing and sequence of events resulting from this EoI shall ultimately be determined by RGPV.
- No oral conversations or agreements with any official, agent, or employee of RGPV shall affect or modify any terms of this EoI and any alleged oral agreement or arrangement made by an agency with any department, agency, official or employee of RGPV shall be superseded by the definitive agreement that results from this EoI process.
